SUBJECT TO STATUTORY CHANGE**

1. The City Council for the City of Bridgeport has determined that the Total Tax Due and Payable on July 1, shall be payable on the following Installments: 1ST INSTALMENT DUE 7/1 THRU 8/1 2ND INSTALLMENT DUE 1/1 THRU 2/1  
No receipt will be mailed to you unless this entire bill and a stamped, self-addressed envelope is included with your payment.
2. INTEREST WILL BE CHARGED at the rate and provisions all in accordance with CONNECTICUT STATE STATUTE SEC.12 1466 now in effect or amended on any delinquent tax payment or part thereof, subject to the minimum interest charge of \$2 or 1.50 percent per month, whichever is greater.
3. Collection Costs will be charged in accordance with Connecticut Public Act 93-318(2) on any delinquent tax or part thereof..
4. Any tax due in excess of 100 dollars shall be payable on 7/1. Motor Vehicle Taxes assessed in accordance with Section 12-7(b) shall also be due and payable in one installment (Supplemental Taxes).
5. TAX DUE MAY BE PAID at Tax Collector's Office or at any agent bank, in July and January only. We encourage payment by mail.
6. TAX LIENS WILL BE FILED ON OR BEFORE 6/30 if any portion of Real Estate Taxes remain unpaid. Such liens may be enforced by levy and sale of such real estate.
7. Motor Vehicle Releases shall be provided only after payment of all taxes assessed in the name of the Registrant(s). PERSONAL CHECKS ARE NOT ACCEPTED FOR PAYMENT OF DELINQUENT MOTOR VEHICLE TAXES. FOR BACK TAXES DUE, CALL 576-7271.
8. Any License or Permit issued by the CITY OF BRIDGEPORT to operate a business enterprise MAY BE WITHHELD OR REVOKED if any taxes levied against personal property used in such business enterprise are delinquent for a period of not less than one year.  
**NOTICE:** The Tax Collector does not determine the amount of the tax, neither can she make adjustments or corrections. All questions involving assessments or exemptions shall be directed to the TAX ASSESSOR'S OFFICE at 576-7241.
